## **Brief Factual Background:**

The Appellant filed Information Request dated 12.04.2019 requesting the following information from the Public Authority:

- 1. The number of children of the estate workers from Kandy, Nuwara-Eliya, Badulla, Kegale, Rathnapura who have been selected to the university entrance during 2014-2019.
- 2. The names of the universities where the above stated students enrolled and the selected courses of them.
- 3. The number of students who have been graduated from the above stated students.
- 4. The details and the current status pertaining to the committee established by the Former President Mahinda Rajapaksa to establish a private university in Nuwara-Eliya district

As the Information Officer failed to respond within the time stipulated under the Act, the Appellant preferred an appeal to the Designated Officer dated 26.06.2019. As the Designated Officer too failed to respond within the time stipulated under the Act, the Appellant appealed to the Commission on 30.07.2019.

## **Matters Arising During the Course of the Hearing:**

Responding to the notice issued by the Commission, the Public Authority, by writing dated 13.08.2020, has drawn the attention of the Appellant to a response dated 12.12.2019, purportedly issued by the Information Officer stating that the Public Authority has arrived at a decision at its 1021<sup>st</sup> meeting held on 07.11.2019, recommending the Appellant to "refer the provisions on "University Order" given in the Universities Act No. 16 of 1978."

## **Order:**

The Commission observes that in responding to the information request made by the Appellant, a mere reference to a "University Order" will not suffice. The "University Order" to which the Appellant's attention is adverted to, in the letter sent by the PA, is general in nature, and makes no reference to a specific date or title of said "University Order." The Commission hereby directs the PA to provide information that is specific to and addresses the information request made by the Appellant.

Order is conveyed to both parties in terms of Rule 27 (3) of the Commission's Rules on Fees and Appeal Procedures (Gazette No. 2004/66, 03.02.2017).
