Brief Factual Background:

The Appellant by request dated 22.12.2017 had requested the following,

- a. Certified copies and/or extracts and/or such other documentary materials which contain and include the basic monthly salary of Mr. N. Vasantha Kumar, Chief Executive Officer/General Manager of the People's Bank for the years 2014,2015,2016 and 2017
- b. Certified copies and/or extracts and/or such other documentary materials which contain and include information on all the allowances for each month of the year 2017 paid to Mr N. Vasantha Kumar, Chief Executive Officer/General Manager of the People's Bank,
- c. Certified copies and/or extracts and/or such other documentary materials which contain and include annual bonuses paid for the years 2014,2015,2016 and that is to be paid for

- 2017 to Mr N. Vasantha Kumar, Chief Executive Officer/General Manger of the People's Bank,
- d. A certified copy and/or extracts and/or such other documentary materials by which the People's Bank informed and sought the concurrence and approval of the Central Bank of Sri Lanka prior to the current basic monthly salary was first paid to Mr N. Vasantha Kumar, Chief Executive Officer/General Manger of the People's Bank,
 - e. A certified copy and/or extracts and/or such other documentary materials by which the People's Bank informed and sought the concurrence and approval of the Secretary to the Treasury prior to the current basic monthly salary was first paid to Mr N. Vasantha Kumar, Chief Executive Officer/General Manger of the People's Bank,
 - f. Certified copies and/or extracts and/or such other documentary materials by which the People's Bank informed and sought the concurrence and approval of the Central Bank of Sri Lanka, prior to the amount of each of the allowances for each month of the year 2017 was first started to be paid to Mr N. Vasantha Kumar, Chief Executive Officer/General Manger of the People's Bank,
 - g. Certified copies and/or extracts and/or such other documentary materials by which the Central Bank of Sri Lanka granted concurrence and approval to the amount of each allowances for each month of the year 2017 when such allowances were first started to be paid to Mr. Mr N. Vasantha Kumar, Chief Executive Officer/General Manger of the People's Bank,
 - h. A certified copy and/or extracts and/or such other documentary materials by which the People's Bank informed and sought the concurrence and approval of the Secretary to the Treasury prior to the amount of each allowances for each month of the year 2017 was first started to be paid to Mr. N. Vasantha Kumar, Chief Executive Officer/General Manger of the People's Bank,
 - i. A certified copies and/or extracts and/or such other documentary materials by which the Secretary to the Treasury granted concurrence and approval to the People's Bank to pay the amount of each of the allowances for each month of the year 2017 when such allowances were first started to be paid to Mr. N. Vasantha Kumar, Chief Executive Officer/General Manger of the People's Bank,
 - j. Certified copies and/or extracts and/or such other documentary materials by which the People's Bank sought concurrence and approval from the Central Bank of Sri Lanka to pay bonuses paid for the years 2014,2015,2016 and that is to be paid for 2017 to Mr. N. Vasantha Kumar, Chief Executive Officer/General Manger of the People's Bank,
 - k. Certified copies and/or extracts and/or such other documentary materials by which the People's Bank sought concurrence and approval from the Central Bank of Sri Lanka to pay bonuses paid for the years 2014,2015,2016 and that is to be paid for 2017 to Mr. N. Vasantha Kumar, Chief Executive Officer/General Manger of the People's Bank,
 - l. A certified copy of the Board decision of the People's Bank to pay such sum of moneys as the bonus for the year 2017 to Mr. N. Vasantha Kumar, Chief Executive Officer/General Manger of the People's Bank,
 - m. A certified copy of the current contract of employment under which Mr. N. Vasantha Kumar, Chief Executive Officer/General Manger of the People's Bank holds his office,
 - n. Certified copies of the original contract of employment Mr. N. Vasantha Kumar, Chief Executive Officer/General Manger of the People's Bank executed at the time he joined the People's Bank and also the subsequent extensions to the said contract of employment,

- o. A certified copy and/or extracts and/or such other documentary materials by which the People's Bank sought concurrence and approval from the Central Bank of Sri Lanka to grant extensions from time to time to the said Mr. N. Vasantha Kumar, Chief Executive Officer/General Manager of the People's Bank,
- p. A certified copy and/or extracts and/or such other documentary materials by which the Central Bank of Sri Lanka granted concurrence and approval to the People's Bank to grant extensions from time to time to the said Mr. N. Vasantha Kumar, Chief Executive Officer/General Manager of the People's Bank,
- q. A certified copy and/or extracts and/or such other documentary materials by which the People's Bank compared and considered the current monthly salary and allowances of the General Manager of the Bank of Ceylon in order to arrive at the decision to fix the current salary and allowances of Mr. N. Vasantha Kumar, Chief Executive Officer/General Manager of the People's Bank,
- r. A certified copy and/or extracts and/or such other documentary materials by which the People's Bank compared and considered the current monthly salary and allowances of the General Manager of the Bank of Ceylon in order to arrive at the decision to fix the current salary and allowances of Mr. N. Vasantha Kumar, Chief Executive Officer/General Manager of the People's Bank and
- s. A certified copy and/or extracts and/or such other documentary materials by which the People's Bank compared and considered the computation of the annual bonus of the General Manager of the Bank of Ceylon in order to arrive at the decision to pay the bonus to Mr. N. Vasantha Kumar, Chief Executive Officer/General Manager of the People's Bank for the years 2014, 2015, 2016 and 2017

By response dated 10.01.2018, the Information Officer (IO) has informed the Appellant that the Public Authority (PA) had sought legal opinion on providing the Appellant- Union with the information sought, and thus a reply will be sent to the Appellant-Union once the legal opinion is received by the PA. Dissatisfied with this response, the Appellant lodged an appeal with the DO on 23.01.2018 to which the DO responded on 06.02.2018 reiterating the response of the IO. Thereafter the Appellant preferred an appeal to the Commission on 28.04.2018.

Matters Arising During the Hearing

Upon being queried by the Commission the Appellant-Union explained the background to the information request. The Appellant-Union submitted that it requested the information pertaining to the salary, allowances and bonuses paid to the General Manager, and documents with regard to the concurrence the PA had obtained from the Treasury and the Central Bank of Sri Lanka with regard to the payments of the same. The Appellant-Union submitted that the General Manager is being paid an exorbitant amount in salary, bonuses and otherwise.

The Appellant-Union further submitted that it requested information pertaining to the General Manager's contract of employment and extensions made to the said contract of employment as well.

Order

The matter is re-fixed for hearing on 17.07.2018 for an in depth consideration of the information requested.

The Appeal is adjourned.

Order

The Public Authority is directed to produce a comprehensive response as to the status of the said inquiry or the decision of the Board appointed Committee on the next date of hearing.

The matter is re-fixed for hearing on 04.09.2018 for consideration of the decision of the Board appointed Committee and to ascertain further steps in relation to the release of the requested information.

The Appeal is adjourned.
