### **Brief Factual Background:**

The Appellant by letter dated 11.01.2018 requested the following information,

- 1. The Cabinet paper dated 2009.09.09 and the corresponding cabinet approval for the interview of Epidemiologist,
- 2. The special marking scheme for the interview (approved by the Cabinet) and
- 3. A Copy of the letter received from the Public Service Commission in January 2018 requesting clarification on the appointment of the Chief Epidemiologist.

As the IO failed to respond within the time period stipulated under the Act the Appellant on 02.03.2018 .lodged and appeal with the DO. As the DO too failed to respond with the time period stipulated under the Act the Appellant preferred an appeal to the Commission on 28.03.2018

### Minute of the Record

Upon being queried by the Commission, the Appellant explained the background on which the information request was based. The Appellant submitted that she was appointed as the Chief Epidemiologist of the Epidemiologist Unit at the Ministry of Health on 18.02.2012, and joined the UN services on a temporary basis on 01.01.2017 with the concurrence of the Ministry. Subsequently the Appellant returned to the Country and reported to the Epidemiologist Unit. Further, she submitted that she was appointed to the Post of Chief Epidemiologist through a special Cabinet decision and learned that Dr. S.A.R. Dissanayaka, Medical Administrator had been appointed as the Chief Epidemiologist. Therefore, the information requested concerns the Appointment of the Chief Epidemiologist to the Epidemiology Unit of the Ministry if Health.

## **Observation**

It is noted, that on the face of the information requested it appears that under and in terms of the Right to Information Act No.12 of 2012 that there is no bar to the release of the information.

As the Public Authority was absent, the Appeal hearing was postponed to 02.10.2018.
