access to information which is in the possession, custody or control of a public authority." Section 43 defines

a 'Citizen' as "a body whether incorporated or unincorporated, if not less than three-fourths of the members

of such body are citizens."

In the instant case the fact of the organisation coming within the ambit of Section 43 of the RTI Act in re the

requisite membership has not been averred before the Public Authority in the information request filed on

3rd February 2017, before the Designated Officer, or before the Commission at the second stage of Appeal

with the relevant documentation to establish that fact.

Preliminary Questions of Law for Determination of the Commission: - Written submissions called for

regarding the below two preliminary questions of law by the Appellant and the Public Authority to be filed

two weeks before the next date of hearing i.e. August 8th, 2017;

1. Whether the requirement of averment of citizenship on the part of the information requestor in

terms of Section 3 (1) of the RTI Act No.12 of 2016 read with Section 43 of the said Act is a

mandatory requirement?

2. Is the said requirement a fatal irregularity or a curable defect at the second stage of appeal before

the Commission?

The hearing of the appeal is adjourned for Continuation in order for the Commission to determine the

aforesaid two preliminary questions of law and in accordance with the request of the Additional Secretary

to the President (Legal) to obtain legal representation for the Public Authority for August 8th, 2017.
