## **Brief Factual Background:**

The Appellant by letter dated 29.06.2018had requested the following information.

- 1. A copy relating to the documents detailing the land management plan of the Southern Expressway area project introduced in 2009.
- 2. Has there been any reforms made to the land management plan of the Southern Expressway area project introduced in 2009? If so, a copy of the relevant document.

- 3. The date on which the UDA regained the delegated powers of the local governments.
- 4. If the detachment of delegated power has been notified by a gazette, the number of the gazette and the date it was published.
- 5. The planning regulation of the UDA relating to 1st of March 1985.
- 6. What are the actions the PA can take at present if a local authority has constructed in the jurisdiction provided in the Southern Expressway land management plan without permission before the detachment of delegated powers?
- 7. Is it compulsory to take permission from the UDA other than a local authority when constructing in the area prescribed in the Sothern Expressway land management plan?
- 8. The management decision no. 21/2016 approved by the UDA management Board on 16.12.2016.

## **Matters Arising During the Hearing:**

By the letter dated 09/01/2019 Right to Information Commission have informed the Public Authority that the Appeal will be taken under the documentary proceedings and further the Public Authority was informed to send statements of objections in writing to the Commission 07 days prior to 06/02/2019 copying to the Appellant. The same was informed to the Appellant from the letter dated 06/02/2019. The Appellant from the letter dated 08/04/2019 addressed to the Director General of the Right to Information Commission have informed that he has received the requested information from the Public Authority.

## Order:

As the requested information has been provided to the Appellant by the Public Authority the Appeal is concluded.
